**1. Call to Order & Introductions**

Scott Leathersich, Planning Committee Chairperson, called the meeting to order at 10:02 a.m. Members, Alternates, and others present introduced themselves.

**2. Public Forum**

Nobody from the public spoke during the Public Forum.

**3. Approval of Minutes**

**William Wright moved to approve the minutes from the February 14, 2018 Planning Committee meeting; Tim Frelier seconded the motion.**

**4. Reports and Action on Old Business**

a. Reports on UPWP Projects and Other Activities

*GTC*

Jim Stack reported:

- 3100 - GTC Strategic Planning:  
Staff has prepared a Self-Certification document to be considered under agenda item 5.f.
- 5200 - Long Range Transportation Plan Update/Implementation:  
No new activity to report.
- 5205 - Genesee-Finger Lakes Scenario Tool:  
A contract has been fully executed. A project kick-off and related work sessions are scheduled for Monday and Tuesday, May 13 and 14.
- 5751 - Genesee-Finger Lakes Regional Local Bridge Vulnerability Assessment:  
The project is being presented for closeout under agenda item 5.b.1.
- 5902 - I-490 Integrated Corridor Management (ICM) Plan:  
No new activity to report.
- 6240 - Vulnerable Users Safety Assessment Program Phases 1 & 2:  
The consultant is finalizing draft reports for each Roadway Safety Audit and has provided about half of them to the respective review teams for review and comment.
- 7110 - Congestion Management Process (CMP):  
GTC staff has integrated the CMP toolbox into LRTP 2040.
- 7115 - Greater Rochester Regional Commuter Choice Program:  
Per the Roceasyride website privacy policy, we need explicit permission to transfer user information to NY511 for migrating to the new platform. GTC staff sent an email to each registered user on May 8. User information will be transferred in early June.
- 7121 - Travel Time Data Collection Program:  
The third and final 1-year option for access to INRIX data was executed on April 22. Staff has met with INRIX to discuss other potential data services. Over the

next several months we will need to determine what traffic data needs we have going forward and issue a new RFP or RFQ to pick up when the current agreement ends.

- 7212 - Lake Ontario State Parkway Lane Transportation Alternatives Feasibility Study:  
NYSDOT is refining operations and maintenance data to support the consultant's analysis. The consultant has indicated that, once they have the refined data, they will be able to wrap up the study in short order. We would then be able to work with the Steering Committee to identify a preferred alternative to present to the public.
- 7620 - Genesee-Finger Lakes Regional Performance Measurement Monitoring & Evaluation System:  
A contract has been fully executed. A project kick-off meeting has been scheduled for May 29.
- 7703 - Transportation Impacts on Economic Development in the Greater Rochester International Airport (GRIA) Area:  
GTC staff is working to schedule meetings with other stakeholders before finalizing the Scope of Work. A Scope of Work is expected to be presented to the Planning Committee in the summer.
- 7900 - Cross Asset Highway and Bridge Evaluation and Prioritization Tool:  
This project is on the backburner. GTC is considering options to rework the RFQ and will make a decision whether or not to reissue it.
- 8170 - Livingston County Human Services Trip Planning Website:  
The project is essentially complete. GTC staff will coordinate with Livingston County on a closeout presentation at a future meeting.
- 8542 - Greater Rochester Transportation Management Association Feasibility Plan:  
No new activity to report.

*G/FLRPC*

David Zorn reported:

- 4103 - Genesee Finger Lakes Region Local Update of Census Addresses 2020:  
Phase 1 is complete. The staff is preparing for feedback to be received by August and is connecting with municipalities to collect new address created in 2018 or later.
- 4220 - Regional Land Use Monitoring Report:  
The report development is underway. Currently awaiting survey responses.

*Monroe County*

Tim Frelier reported:

- 4210 - Monroe County Land Use Monitoring:  
Have heard from all municipalities who will provide information by July in order to have a Draft Report by September.

- 6230 - Monroe County High Accident Location Program:  
Two additional locations have been completed since the February Planning Committee meeting. 30 out of 49 locations have been completed to date.

## *NYS DOT*

Jim Stack reported:

- 6232 - NYS DOT Safety Investigations and Analysis:  
A contract has been fully executed. After discussion among the project team, it has been decided that the most efficient way to progress this project is to analyze the Route 15 (West Henrietta Road) corridor in support of a forthcoming scoping effort.
- 7951 - O'Rorke Bridge Operations and Maintenance Analysis and Strategy:  
The Scope of Work needs to be developed

## *Ontario County*

Jim Stack reported:

- 8777 - Ontario County SR 364/CR 11 Active Transportation Corridor Plan:  
A joint back-to-back meeting of Steering Committees for this project (kick off meeting) and the Lake Shore County Parks study (final meeting) was held April 2. GTC Staff has provided crash data for the project area. The parks study is wrapping up and has identified traffic issues that will inform this study.

## *City of Rochester*

Erik Frisch reported:

- 7702 - City of Rochester Comprehensive Access & Mobility Plan:  
The final Project Steering Committee meeting was held in February. Final revisions to the Priority Projects deliverable and Rochester Street Design Guide are undergoing an internal review. The consultant is finalizing the final report.

Eric Farr reported:

- 8426 - RTS Access Ridership and Facility Evaluation:  
The project is expected to close out in July.
- 8538 - RTS System Redesign:  
The final report will be presented at the June 29 RGRTA Board of Commissioners meeting. Implementation (new service network rollout) is expected in June 2020.
- 8541 - Mobility Management Implementation Study:  
RTS has received the final draft report from the consultant and is working on scheduling a project close-out either in this summer.

GTC staff has been working with Wayne County Planning on a Scope of Work that is expected to be presented at the July Planning Committee meeting.

Jim Stack reported:

- 6518 - Route 390 Multi-Use Trail Restoration and Safety Improvement Study:  
The Town of Greece reached out to GTC staff last week to put a pause on the project to reassess the impact of Canal Corp. plans on the Canalway Trail and NYS DOT plans for the Route 390 Trail.
- 6812 - Honeoye Falls Circulation, Accessibility, and Parking (CAP) Study:  
The project kick-off meeting was held on March 5. The consultant team is making progress on inventorying existing conditions.
- 6813 - Penn Yan Circulation, Accessibility, and Parking (CAP) Study:  
A Steering Committee meeting was held May 8. The existing conditions report is complete. The next Steering Committee meeting will be held in June.
- 7577 - Mt. Morris-Leicester Route 36 Corridor Study:  
A stakeholder meeting is scheduled for May 20 so the particulars of the project can be discussed. A Scope of Work is expected to be presented in the summer.
- 8764 - Pittsford Active Transportation Plan:  
Project was accepted by the GTC Board at its March 7, 2019 meeting.
- 8774 - Geneseo Active Transportation Plan:  
Consulting team has conducted the inventory and identified priority intersections. The team has completed field work and conducted a debriefing session.

A project kick-off meeting was held April 25.

The second Steering Committee meeting was held on April 10. The project is progressing well.

Federal Legislative and Funding Update

There has not been much happening in this topic. Recent media reports have indicated that President Trump, Speaker Pelosi, and Senator Schumer have agreed to pursue an infrastructure package worth up to \$2 trillion. There is no indication as to when this plan will progress.

GTC Staff

Bob Williams joined the GTC Staff on April 29. Bob will be focused on active transportation and public transportation matters. Bob comes to GTC from his prior position at Nelson/Nygaard.

b. Recommendation to the GTC Board concerning **accepting reports as evidence of completion of a UPWP Task**

Fred Frank presented the Executive Summary of the project. He noted that the project assessed the vulnerability of local bridges located along non-federal aid roadways in the Genesee-Finger Lakes Region to natural and human-caused hazards and propose strategies for preventing and/or mitigating the impacts of hazard events on those bridges. This study focused on bridges located along non-federal aid local roads. Further, this assessment provides an on-site assessment of nineteen local bridges, selected by county highway superintendents.

2. Recommendation to the GTC Board concerning **accepting the *Uptown Canandaigua Mixed-Use and Transportation Corridor Feasibility Study* as evidence of completion of UPWP Task 7704** / Proposed Council Resolution 19-29 (Town of Canandaigua)

Kimberly Baptiste presented the Executive Summary of the project. The Town developed a multi-modal transportation plan coupled with an action-oriented economic development plan to identify a strategy to transform the Uptown Canandaigua Corridor. The purpose of this study was to present projects and actions that will facilitate the enhancement of Uptown Canandaigua into a

vibrant, mixed-use corridor that is inclusive for all residents and visitors of all ages and abilities.

**Erik Frisch moved to recommend that the GTC Board adopt proposed Resolutions 19-28 and 19-29; Dave Hartman seconded the motion. The motion pass unopposed.**

- c. Recommendation to the GTC Board concerning **amending the *FY 2019-2020 UPWP* to reflect the contribution of actual FY 2018-2019 rollover amounts** / Proposed Council Resolution 19-30 (GTC staff)

James Stack provided the following report:

The adopted FY 2019-2020 UPWP includes estimated rollover amounts for several projects that were not expected to be completed by March 31, 2019. These estimated rollover amounts were based on actual expenses through the second quarter. Now that the accounting for FY 2018-2019 has been closed out, the budgets for these projects for FY 2019-2020 can be adjusted to reflect actual rollover amounts.

Individual projects for which adjustments between estimated and actual rollover amounts are required are presented in Exhibit 1 of the Resolution.

You will recall that at the February 14 meeting, GTC staff noted that we were working with NYSDOT Main Office staff to verify balances of unspent funds from prior years that are referred to as Backlog/Savings. At the time, we knew there would be enough revenue available to fully fund the requested amount for new UPWP projects for which the UPWP Development Committee could recommended only partial funding. The Planning Committee agreed with this change and the adopted UPWP reflected those amounts.

GTC staff has been able to confirm the remaining balance of the Backlog/Savings at \$475,763. In order to protect this balance from possibly being lost via the FAST Act Rescission, GTC staff is proposing to add these funds to Task 5200 – Long Range Transportation Plan Development and Implementation to support an updated Regional Household Travel Survey. This survey is critical to supporting our federal requirement to have a Travel Demand Model that represents travel characteristics in our region. This change is also reflected in Exhibit 1 to the Resolution.

The last time we conducted a Household Travel Survey was in 2011. The state of the practice suggests conducting a Household Travel Survey in a timeframe that allows comparison to other major demographic data, such as what we will get from the 2020 Census. For comparison, the contract for the last Household Travel Survey was over \$500,000. GTC staff intends to explore alternatives methods of getting suitable travel information in a less costly way.

**Mitch Rowe motioned to recommend that the GTC Board approve proposed Resolution 19-52; Tim Frelier seconded the motion. The motion passed unopposed.**

- h. Recommendation to the GTC Board concerning **adopting the *2020-2024 Transportation Improvement Program*** / Proposed Council Resolution 19-54 (GTC staff)

During much discussion on the draft TIP, Planning Committee members expressed concern with the limited time they had to review project details and schedules. There was general discomfort on making a recommendation to the GTC Board at this time. After discussing various options, it was agreed that:

- The Draft 2020-2024 TIP project lists should be made available for public review;
- The public meetings for the Draft 2020-2024 TIP should progress as scheduled;
- GTC staff would continue to work with project sponsors to refine the project schedules to develop a fiscally constrained program;
- Responsibility to make a final recommendation to the GTC Board will be delegated to the TIP Development Committee (TDC), which will meet on May 29;
- The TDC will consider any public comments received by their May 29 meeting before making a final recommendation; and
- Any public comments received after the May 29 TDC meeting will be provided directly to the GTC Board for consideration before taking action on the proposed 2020-2024 TIP.

**Mitch Rowe motioned to approve the Draft 2020-2024 TIP for public review; Tim Frelier seconded the motion. The motion passed unopposed.**

**Mitch Rowe motioned to delegate responsibility to recommend particular action by GTC Board regarding proposed Resolution 19-52; Tim Frelier seconded the motion. The motion passed unopposed.**

**6. New Business**

Joel Kleinberg noted that the State is transitioning to new a financial software platform in June, which will result in a blackout period for certain transactions. Regional Local Project Liaisons (RLPL) are working with project sponsors but Joel wanted to be sure member agencies were aware of the change.

**7. Public Forum**

Terry Rice inquired about the status of local projects in regards to the expected FAST ACT rescission at the end of FFY 2019. Joel Kleinberg responded that local sponsors were informed of all unobligated phases remaining in the current FFY. He added that RLPLs have been coordinating with those sponsors to ensure obligation or relevant TIP action.

**8. Next Meeting:**

Jim Stack noted that the next meeting is scheduled for July 11, 2019 at Monroe County Fleet Center, Building 10, 145 Paul Road in Chili.
