SUBJECT: Staff Modifications to the *2023-2027 Transportation Improvement Program*

The *GTC TIP Procedures Manual* (revised August 26, 2021) allows for GTC staff to make minor modifications to TIP projects with concurrence from the TIP Development Committee (TDC). The Procedures Manual requires that these changes be reported to the GTC Board for informational purposes.

On October 20, the TDC raised no objections to the following change:

- Add new non-Federal funding for the **Rt 14 within former Village of Lyons Preventive Maintenance** project (NYSDOT)
- Add new non-Federal funding for the **Rt 31, from Monroe CL to Hamlet of Macedon Preventive Maintenance** project (NYSDOT)
- Add new non-Federal funding for the **Rt 104 from Lake Ave to Culver Rd, MbC** project (NYSDOT)
- Add new non-Federal funding for the **Rt 204 from Rt 33A to Rochester City Line Preventive Maintenance** project (NYSDOT)
- Add new non-Federal funding for the **Rt 286 from Rochester City Line to Qualtrough Rd Preventive Maintenance** project (NYSDOT)
- Add new non-Federal funding for the **I-390 at Rt 383 (Scottsville Rd) Intersection Safety Improvements** project (NYSDOT)
- Add new non-Federal funding for the **Rt 260 from Rt 31 to Rt 104 & Rt 31 from Transit Way to west of Salmon Creek Preventive Maintenance** project (NYSDOT)
- Add new non-Federal funding for the **Rt 250 over Thomas Creek Bridge Replacement** project (NYSDOT)
- Modification to phases with no change in Total Cost or Federal Share for the **Bus Stop Amenities** project (RGRTA)
- Modification to phases with no change in Total Cost or Federal Share for the **Main Street Streetscape Phase III** project (City of Rochester)
- Add new non-Federal funding for the **Tileyard Rd over Flint Creek Bridge Replacement** project (Ontario County)

On November 17, the TDC raised no objections to the following change:

- Add new non-Federal funding for the **Rt 104 from Lake Ave to Culver Rd, MbC** project (NYSDOT)
- Add new non-Federal funding for the **Rt 260 from Rt 31 to Rt 104 & Rt 31 from Transit Way to west of Salmon Creek Preventive Maintenance** project (NYSDOT)

- Change in Project Name for the **I-490 over Genesee River Bridge Rehabilitation Preventive Maintenance** project (NYSDOT)
- Modify phases with no change in Total Cost or Federal Share for the **Bull's Head Revitalization** project (NYSDOT)
